## **CCSD 4-Year Graduation Rates for SY 17-18**

**District – 79.9%**

**Collins High School – 83.1%**

**Mt. Olive Attendance Center – 78.1%**

**Seminary High School – 78.2%**

The graduation rate goal set by the Mississippi State Board of Education to comply with Mississippi Code Ann. § 37-13-80 is 81%. The following district plan is implemented in pursuit of that goal for School Year 2018-2019.

District Goal One: Implement fully the Literacy Promotion Act to increase literacy proficiency in grades Kindergarten through third grade.

Professional Learning Communities

- Professional Learning Communities will meet weekly in the all elementary schools to continually review the School Literacy Plan and the progress of implementation of that plan.
- Professional Learning Communities meet weekly in all schools to address student needs. PLC's are formed as grade level, subject area and special areas to address literacy needs.
- Teachers will meet monthly in district wide PLC's to communicate outcomes of the implementation of the School Literacy Plan at each school.

Assessment Strategies

- All students in grades Kindergarten through third grade will be assessed using the district adopted screening assessment.
- Progress of all Covington County students in grades Kindergarten through 11<sup>th</sup> grade will be assessed throughout the year; classroom instruction will be designed based on the progress monitoring data.

Common Planning by Grade Levels

- Common planning for teachers will continue for literacy teachers in grades Kindergarten through third at all elementary schools
- Elementary Principals will coordinate scheduling meetings and acquiring resources etc. for implementation of the School Literacy Plan

90 minute Literacy Block

- All elementary schools will provide a 90 minute uninterrupted block of time built into the master schedule for grade kindergarten through third grade for literacy instruction.
- The literacy block will include whole group instruction, literacy centers instruction, writing instruction, listening and speaking instruction.

District Goal Two: The Covington County School District has set a graduation rate goal of 85% for School Year 2018-2019.

- Covington County School graduation data will be reviewed and all rates per subgroup will be determined.
- Each high school will implement action steps within the School Restructuring Plan that addresses each subgroup.(see school plan)
- The proposed changes to graduation requirements will be inform all decisions of implementation of this plan throughout 18-19 school year.

District Goal Three: To provide an avenue for students ages 17 - 21 to access a GED curriculum.

- Students ages 17 – 21 who are no longer required to attend school under the Compulsory School Law may attend GED preparation courses at Jones College.

District Goal Four: To provide an avenue for students who are returning to Covington County School District from a youth detention center and to implement procedures in keeping with accreditation standard 32 and CCSD Board Policy JDG.

32. The school district complies with state statute and State Board of Education policy for education of juveniles in youth detention centers.

- An individual plan will be designed for that student. Covington County School District Policy JDG – Readmission and Denial of Admission will be used as a guideline for designing the student’s plan. Whenever possible students will access all programs provided to Covington County School District students.
